



# Celebrating our history and looking forward to the future

- EPLF celebrated its 30th anniversary (1994-2024)
- Introduction of new Affiliate member category
  - Retain members who stopped producing but continue to sell laminate flooring
  - Bring the value chain closer to EPLF (distributors, customers, trade partners)
- Significant growth over the years: from 8 to 48 members
  - 12 Ordinary members
  - 23 Associate members
  - 11 Supporting members
  - 2 Affiliate members





## Acting as the voice of the industry

### **Sustainability and Circularity**

- Work on collection, sorting and recycling of laminate flooring
- Cooperation with other flooring associations, incl. participation in sorting trials

#### Trade

 Successful application for new Customs Codes for laminate flooring:

4411 13 91 (thickness 5-9 mm) 4411 14 91 (thickness >9 mm)

 Codes applicable as of 1 January 2025. Will help better track and assess trade flows between EUthird countries, and within the EU

#### Competitiveness

- Endorsed joint industry statements about avoiding market fragmentation and ensuring level playing field under the PPWR (Packaging and Packaging Waste Regulation, and relaunching European competitiveness and the EU single market. Position papers are available on EPLF website
- Signed the <u>Antwerp Declaration</u> calling for a European Industrial Deal to complement the EU Green Deal and safeguard the quality of jobs in Europe

## Sustainability and Circular Economy®

- Ad-hoc group on Circular Economy worked on collection, sorting and recycling:
  - Looking into available sorting and recycling technologies for laminate flooring
  - Partnering with ERFMI and MMFA to discuss what sorting systems would make sense on the market
  - Participating in two sorting tests with MMFA and TOMRA
- New Technical Bulletin on R-Strategies and Lifespan of Laminate Floor Coverings
  published in November 2024 (available in English and German on the Information Material
  section of EPLF website)
- EPLF's Environmental Product Declaration (EPD) is now available in French on EPLF website
- In 2025, the Technical Committee will carry out further research on technical solutions (for collection and sorting) and will continue cooperating with other associations



### **CEN-related work**

#### **CENTC 134 WG 09**

#### **EU standard for laminate floors**

- Discussing an amendment to EN 13329:2023-12:
  - Herringbone installation (tests and requirements)
  - Calibration value for abrasion test
- Started systematic review of EN 16354 (Underlays)
  - o Specifications, requirements and test methods

#### **CENTC 134 WG 10**

#### **EU standard on Circular Economy**

- New standard FprEN CEN/TS 18075 was approved
  - o Focuses on design throughout a product's lifetime
- prEN vote to be organised on version 9 of Product Passport
   Document
  - Adapted to all types of flooring covered by CEN TC 134
  - 2 levels of information: unified code (generic information); use and end-of-life (product circularity)

#### **Harmonised test methods**

- Vote on revision of prEN 1815 was successful Several test parameters now described more in details
- Vote on revision of prEN 16810:2024 is finished Underlays and MMF floor coverings were integrated

### **ISO-related work**

#### **ISO TC 219 WG 3**

#### **International standards for laminate floors**

- Revised draft of ISO DIS 14486 will be sent to vote.
  - To correct issues with definition of laminate floor covering as a substrate with 65% wood content
  - Locking strength requirements for herringbone installation was reduced

#### **ISO TC 219 WG 4**

#### **Harmonised test methods**

- Vote on the revised ISO 4918 for Castor Chair test method for textile, resilient, MMF and laminate floors was successful
  - The assessment parameters were improved
- Revision of ISO 6356:2012 for textile and laminate floor coverings has started. The laminate group has requested for the test parameter in EN 1815 and the future ISO 6356 to be equal






### Sales of laminate stabilising

World market 2008 - 2024 Sales of EPLF members in mil m<sup>2</sup> **European Production** 




### Slight decrease of sales in Europe






# Western Europe remains the largest market




### Germany leads the pack in Western Europe 18



Western Europe 2024 Sales of EPLF members in mil m<sup>2</sup> European Production




### Mixed markets in Eastern Europe






### Russia took lion's share again


